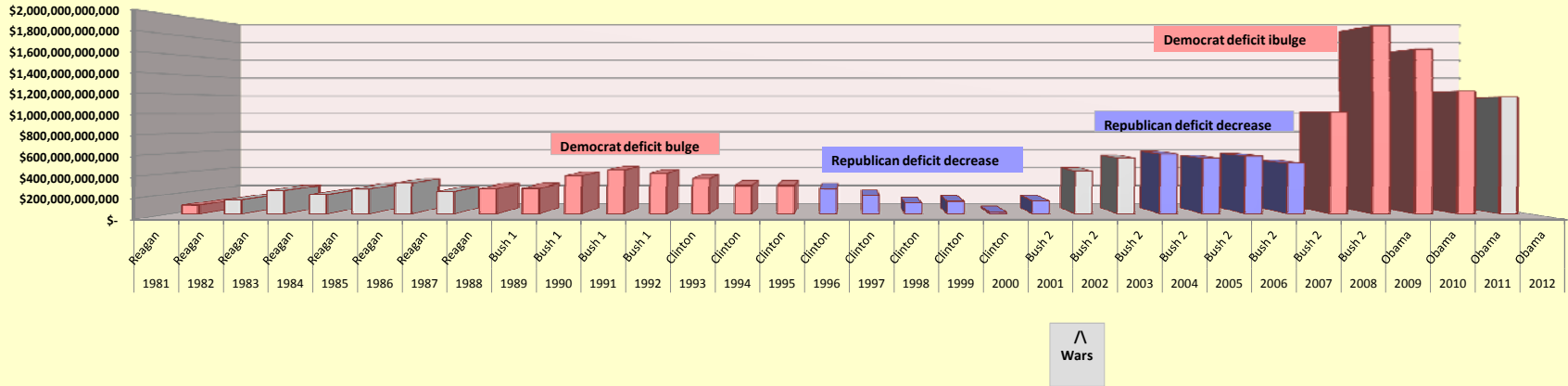


## Increase in outstanding debt of the U.S. federal government ( Red = Democrat Congress, Blue = Republican Congress, Grey = split Congress )
